

**SECOND RENEWAL OF AGREEMENT (YEAR-5)
FOR PURCHASE AND SALE OF GOODS**

THIS SECOND RENEWAL (YEAR-5) is made and entered into on this 13th day of **September 2021** by and between the **City of Naples** and **Olympic Compactor Rentals, Inc.**

WHEREAS, the City ("City") and **Olympic Compactor Rentals, Inc.**, ("Vendor") entered into that certain Agreement dated the 1st day of October, 2017 for the Annual Rental of Solid Waste Compactors utilized by the Utilities Solid Waste Department (**Bid No. ITB 17-031, Clerk Tracking No. 2017-00132**) ("**Agreement**"); and

WHEREAS, the duration of the Agreement was for an initial term of three (3) year(s) with an option for the parties to renew the Agreement for two (2) additional one (1) year terms;

WHEREAS, the Agreement will expire on the 30th day of September, 2021 and the Vendor is willing to renew the Agreement for an additional one (1) year term with no change in price; and

WHEREAS, the City Manager finds and has determined that the Vendor has successfully fulfilled its obligations under the Agreement since the Agreement began and that renewal for an additional year is in the best interest of the City; and

WHEREAS, the City Manager is authorized pursuant to Section 2-667 (7)(e), to exercise the option to renew the Agreement for an additional year on behalf of the City.

NOW, THEREFORE, in consideration of the mutual covenants and understandings set forth herein, the parties agree as follows:

1. The above recited "Whereas" clauses are incorporated by reference.
2. The term of the Agreement is now renewed for an additional 1-year term (Year-5) to expire on the 30th day of September 2022 with no available renewals. Extensions of said Agreement for Years 6-7 upon mutual agreement between the City & Vendor would require City Council approval.
3. Unless otherwise stated herein, all terms and conditions of the Agreement remain in full force and effect.





This Affidavit is required and should be signed by an authorized principal of the firm, notarized and submitted with formal Invitations to Bid (ITB's) and Request for Proposals (RFP) submittals. Further, Vendors / Bidders are required to enroll in the E-Verify program, and provide acceptable evidence of their enrollment, at the time of the submission of the vendor's/ bidder's proposal. Acceptable evidence consists of a copy of the properly completed E-Verify Company Profile page or a copy of the fully executed E-Verify Memorandum of Understanding for the company. Failure to sign this Affidavit and acceptable evidence of enrollment in the E-Verify program, may deem the (Vendor / Bidder) being a Contractor, Firm, Consultant, etc., and the Issued Task Order Amendment as non-acceptable to the CITY.

City of Naples will not intentionally award CITY contracts to any vendor who knowingly employs unauthorized alien workers, constituting a violation of the employment provision contained in 8 U.S.C. Section 1324 a(e) Section 274A(e) of the Immigration and Nationality Act ("INA").

City of Naples may consider the employment by any vendor of unauthorized aliens a violation of Section 274A (e) of the INA. Such Violation by the recipient of the Employment Provisions contained in Section 274A (e) of the INA shall be grounds for unilateral termination of the contract by City of Naples.

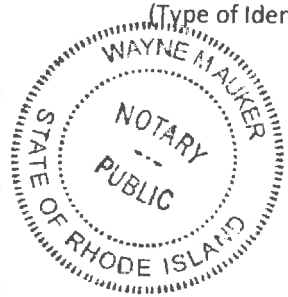
