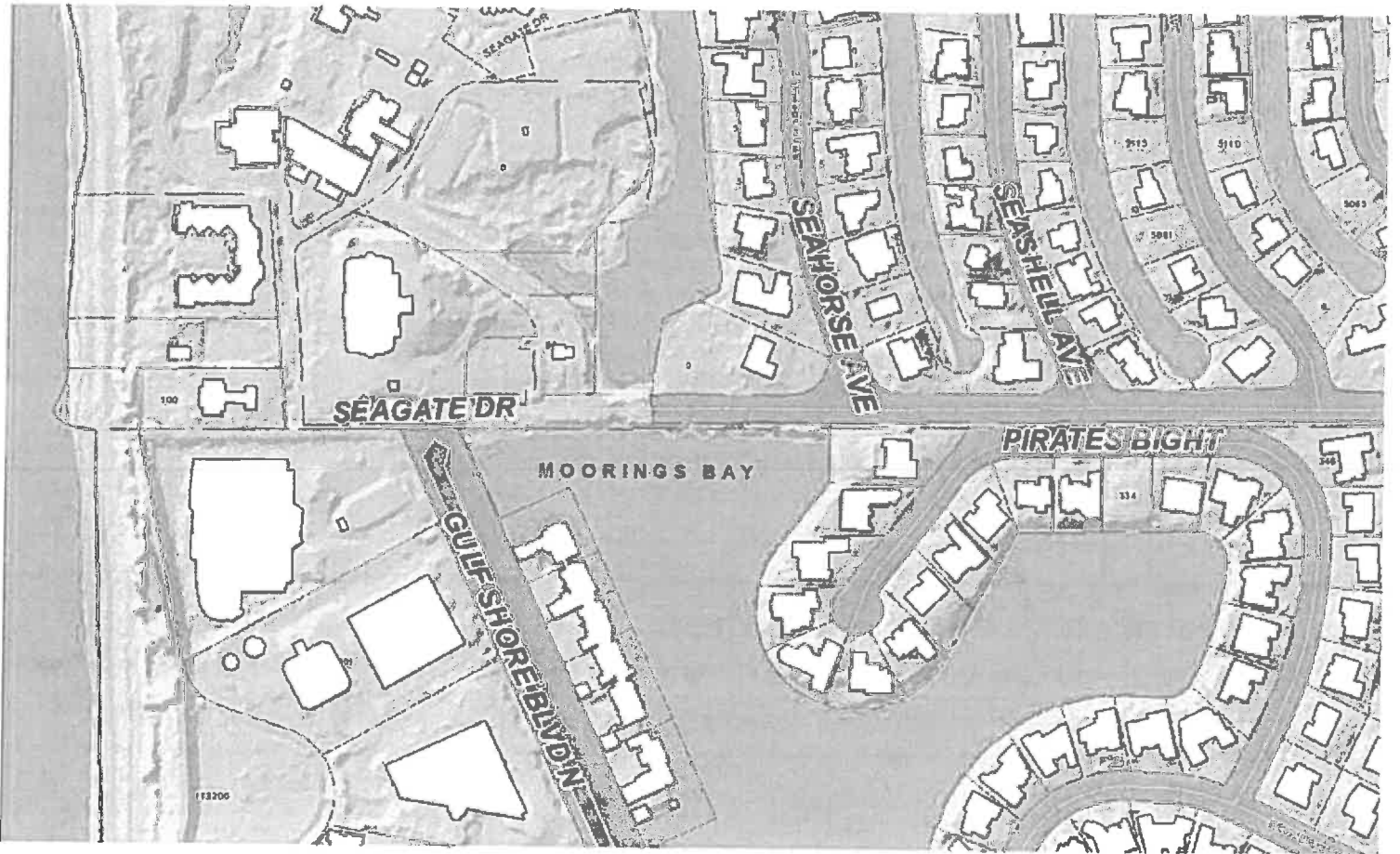


Exhibit A - Revised Lake Location Maps

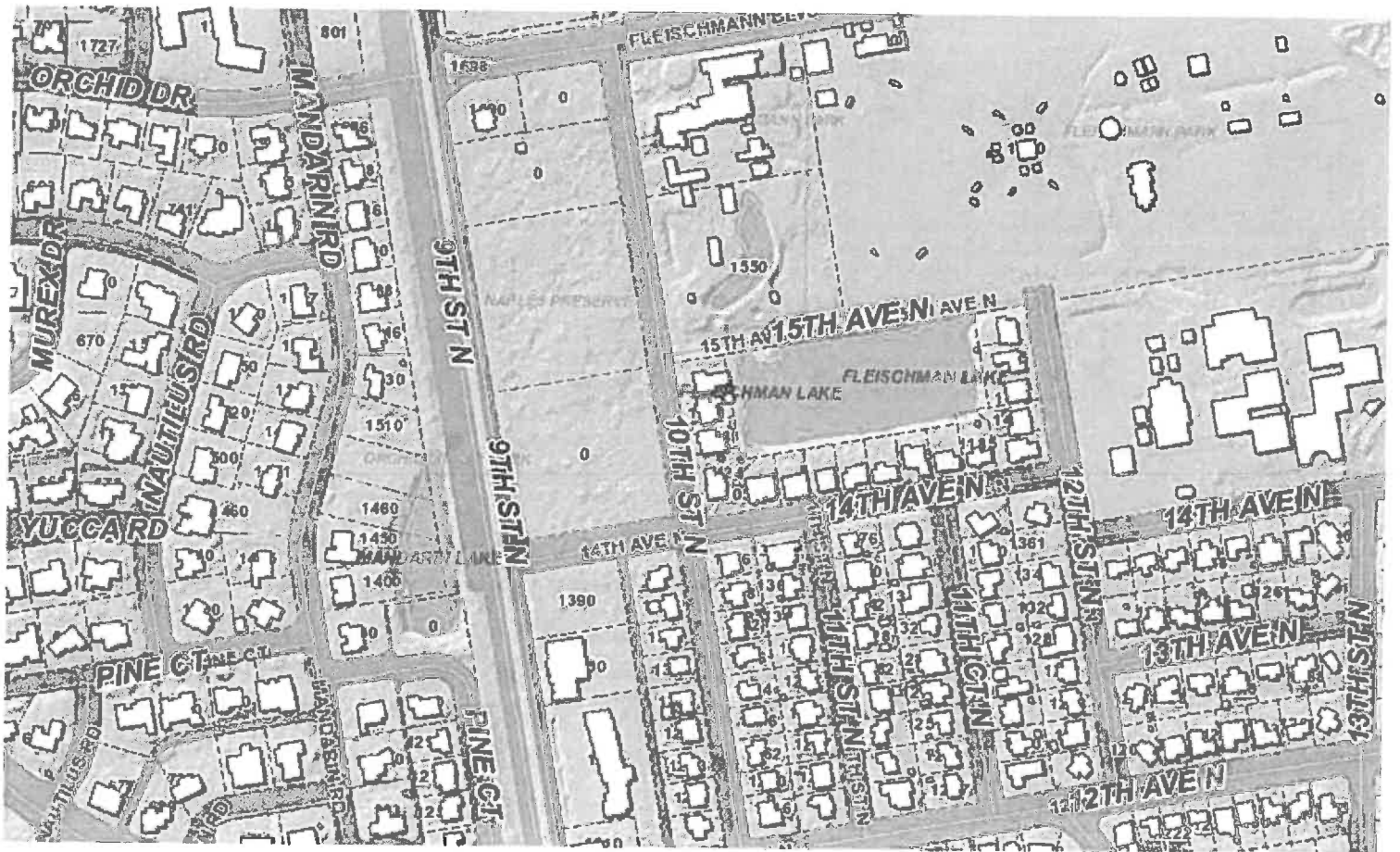

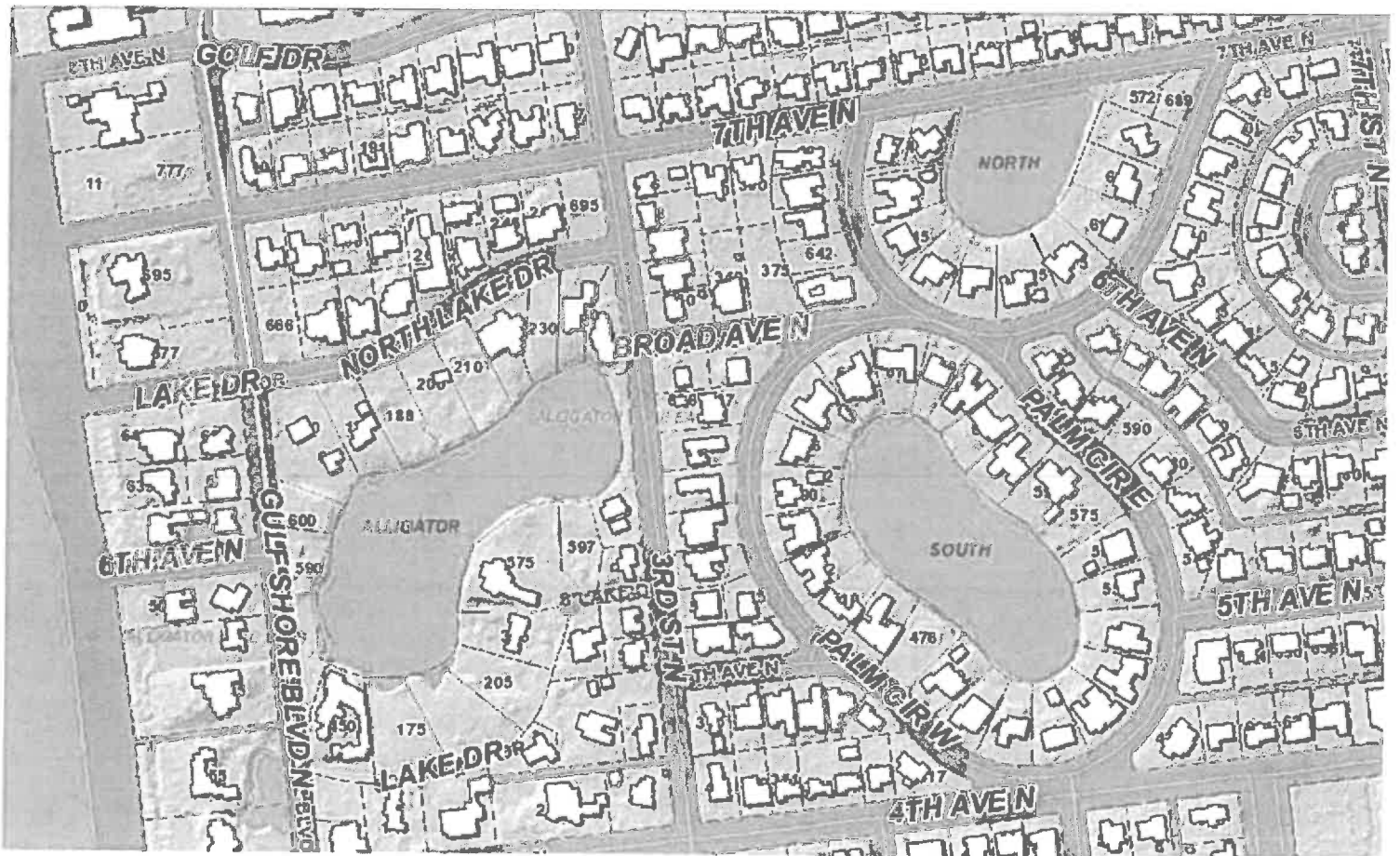




MANDARIN LAKE and FLEISCHMANN LAKE

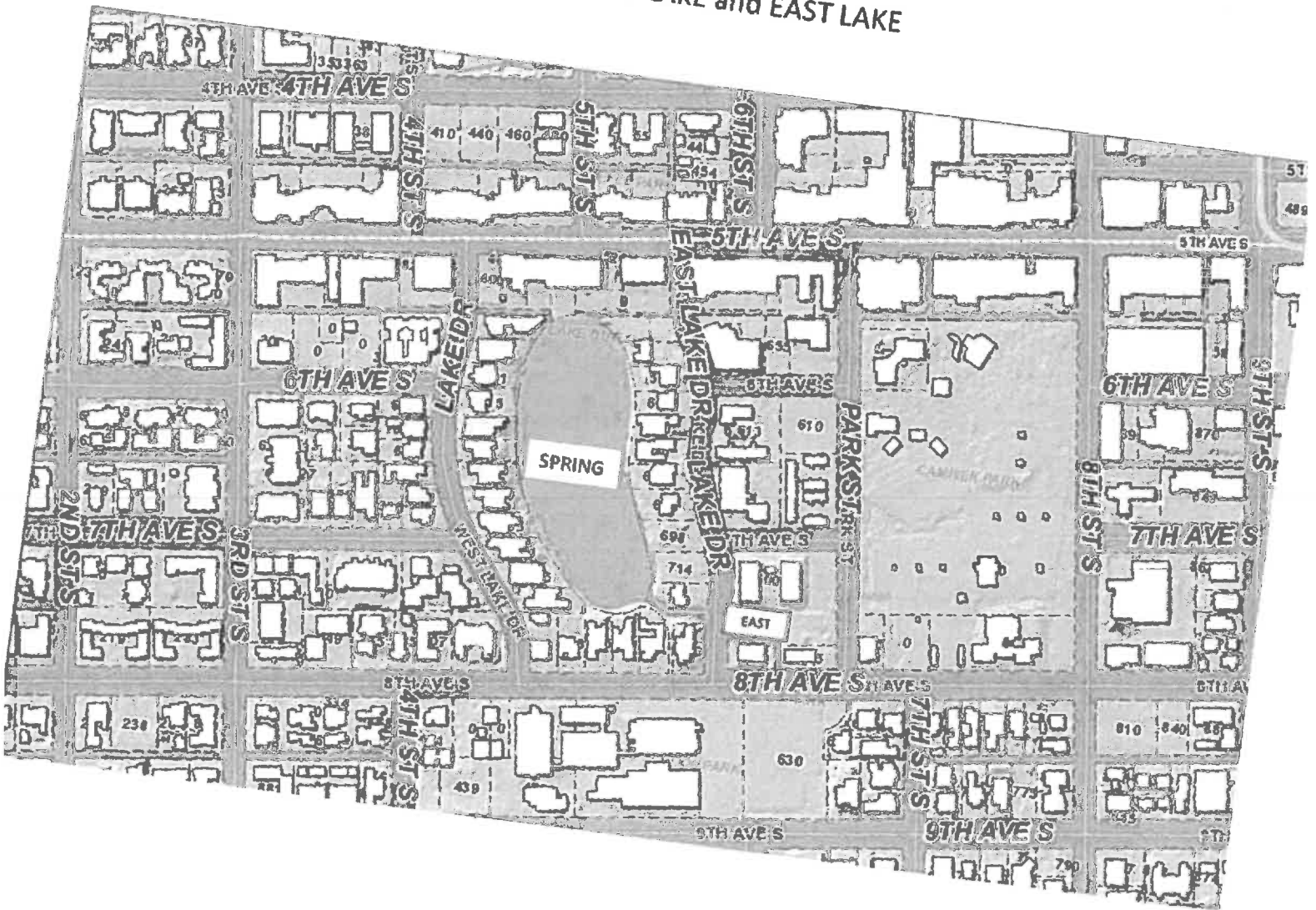


NORTH LAKE, SOUTH LAKE, and ALLIGATOR LAKE

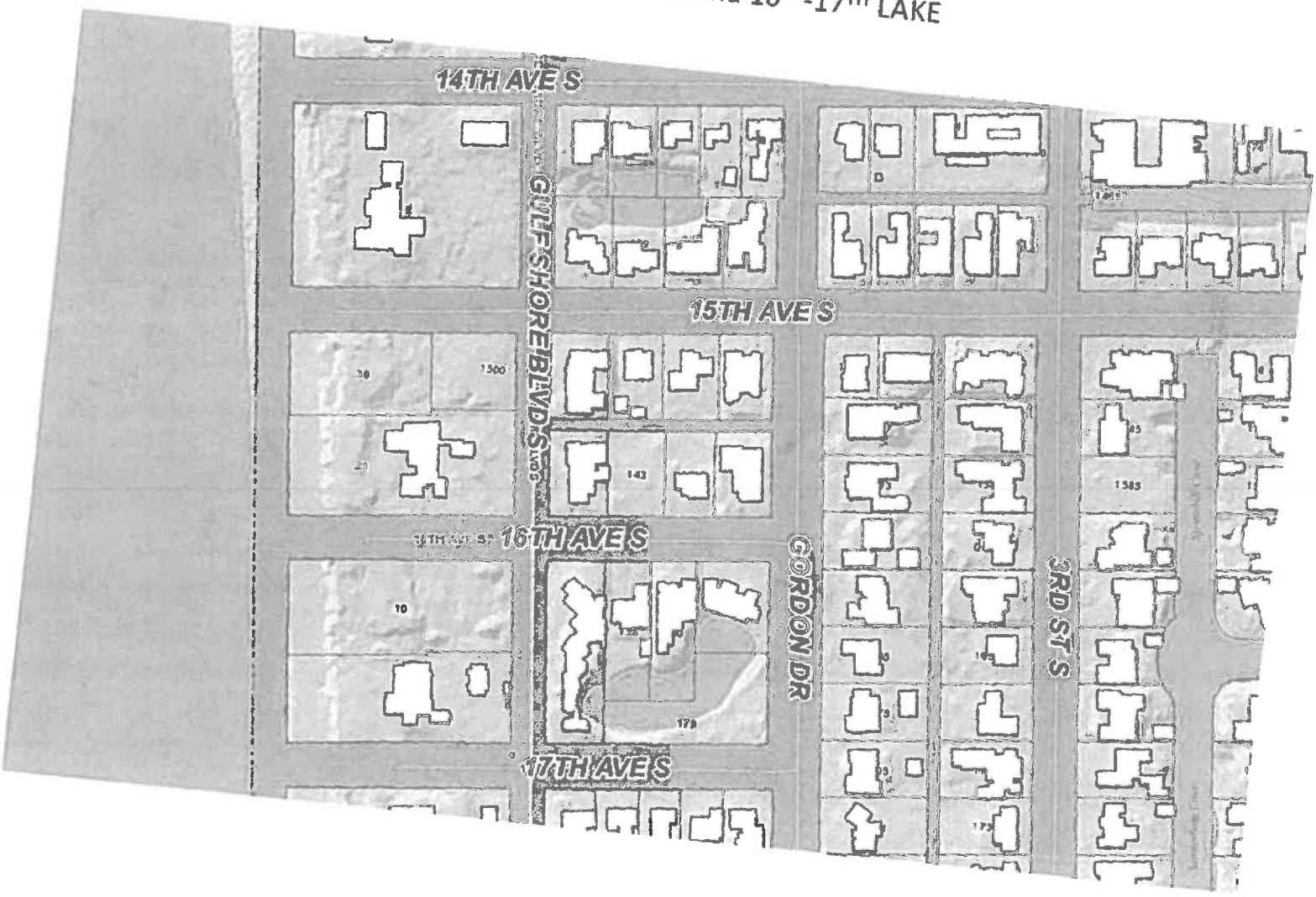




# SPRING LAKE and EAST LAKE

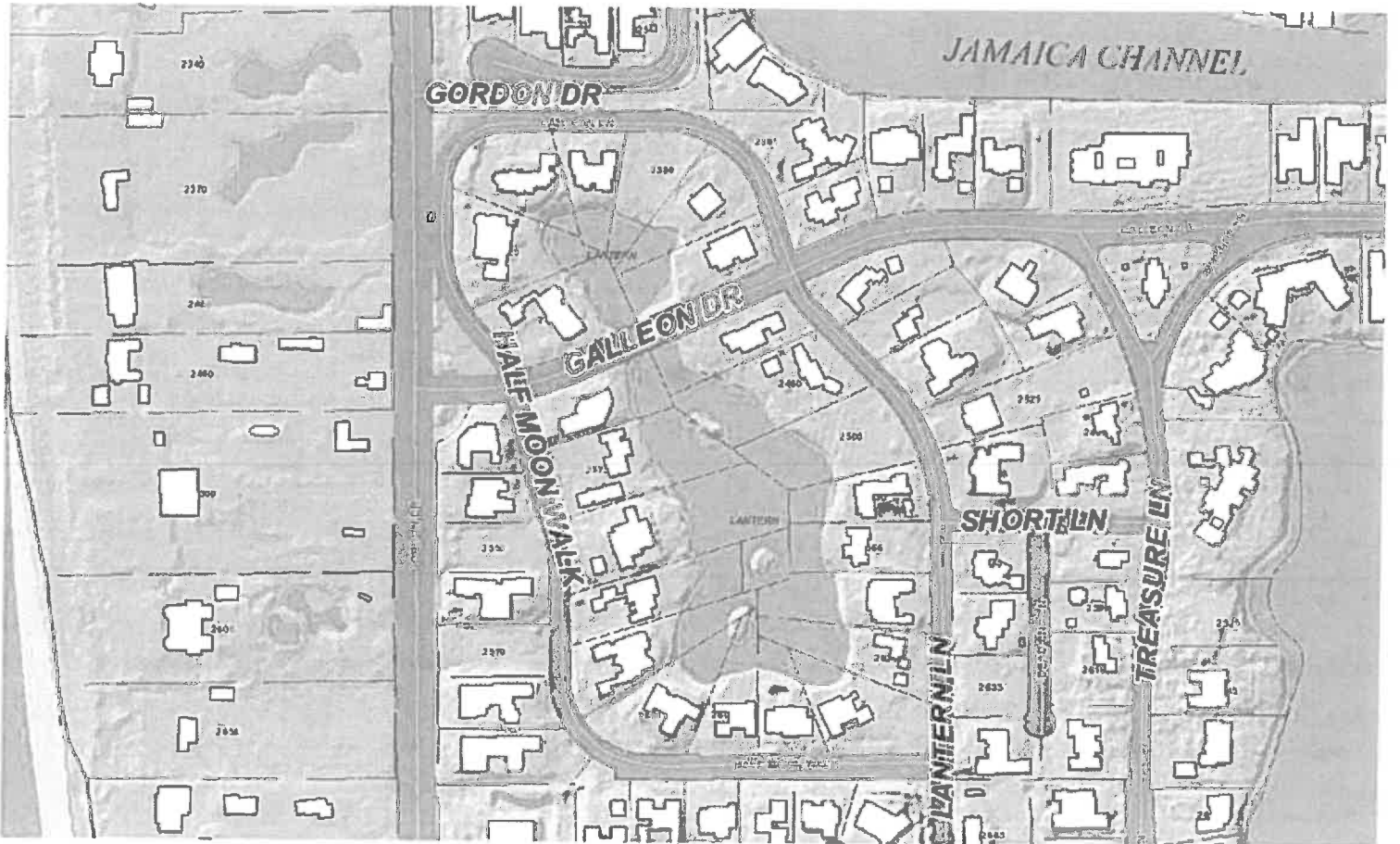

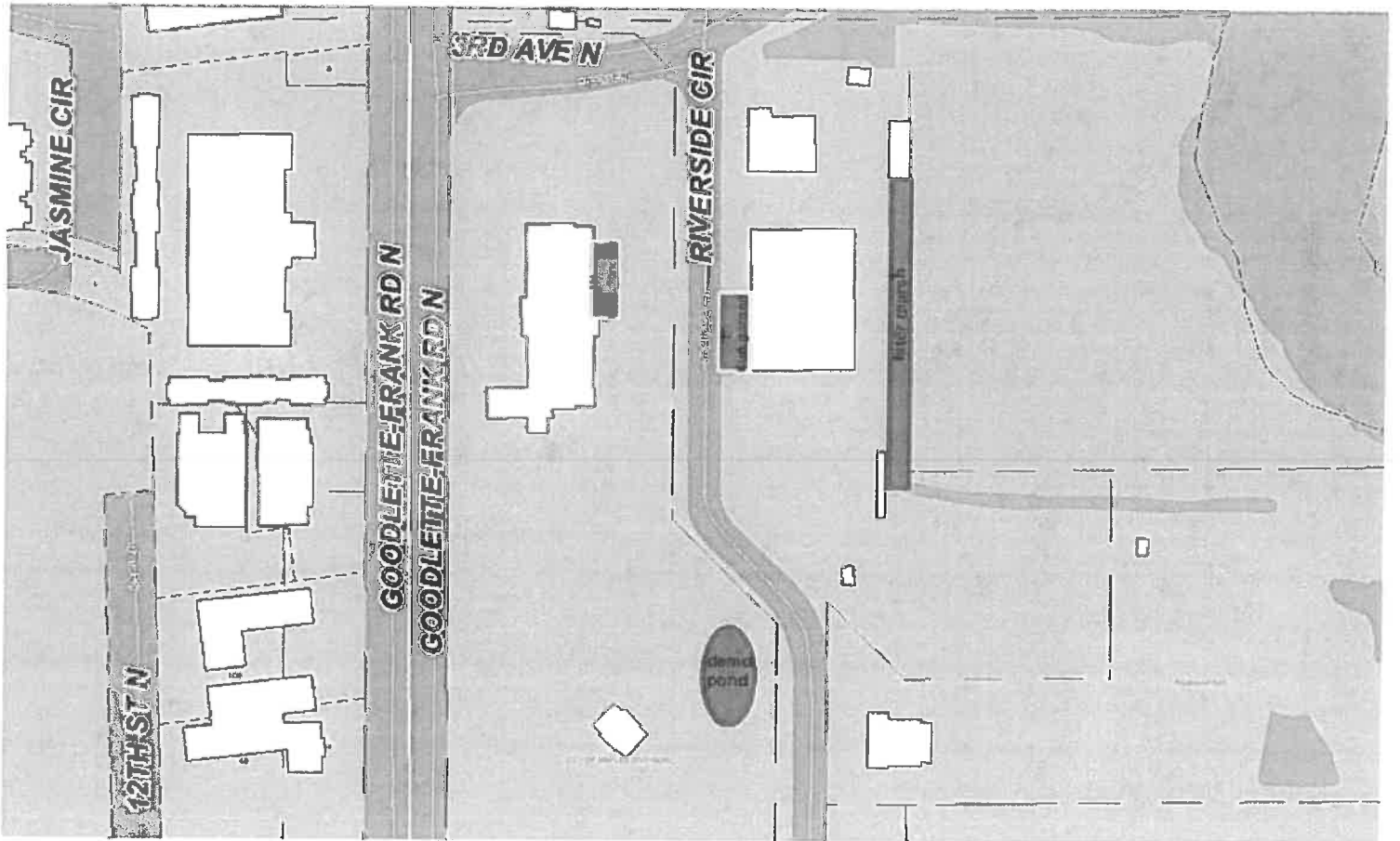
