1. Project Plans and Specification – General

The existing conveyor system from the identified location on sheet M-1 and M-8 to that shown on sheet M-3 shall be removed in its entirety. This shall include but not be limited to the existing conveyor, existing conveyor support beams, drip pans, wash water system, miscellaneous electrical and drive units. The existing drive unit in the Sludge Dewatering Building shall be reused on the new conveyor extension. Existing electrical and wash water shall be extended from the Sludge Dewatering Building. One existing support shall be modified and moved to the east wall and another existing support shall be modified for the new conveyor extension. It is the Contractor's option of reusing and rehabbing these supports or providing new supports.

2. Project Plans and Specifications – General

An extended stainless steel chute shall be provided on the existing drive unit/hopper (being relocated from the Sludge Dewatering Building). This chute should direct the discharge to the center of the existing truck scale.

3. Specifications – Summary and Sequence of Work, Paragraph 1.03 (B), Additional Clarification.

During the conveyor work, a prearranged five day shut-down is specified from May 1 to November 30 and a prearranged two day shutdown between December 1 and April 30. The Contractor may request multiple shutdowns; however, the City must be able to operate the conveyor system between shutdowns to produce a dry material and discharge it into the truck bay. A minimum of five days shall be provided between shutdowns.

4. The following list below is an additional information list of manufacturers, suppliers and subcontractors that could potentially be utilized to complete the required work for the City of Naples Sludge Dewatering & Stabilization Buildings Modification Project.
