GENERAL CONDITIONS

TO ENSURE ACCEPTANCE OF THE PROPOSAL, PLEASE FOLLOW THESE INSTRUCTIONS. ANY AND ALL SPECIAL CONDITIONS, ATTACHED HERETO, HAVE PRECEDENCE.

- 1. SEALED PROPOSAL:** All proposals must be submitted in a sealed envelope. The face of the envelope shall contain the proposal name and proposal number. Proposals not submitted on attached proposal form shall be rejected. All proposals are subject to the conditions specified herein. Those which do not comply with these conditions are subject to rejection.
- 2. DEFINITIONS:** Uses of the following terms are interchangeable as referenced: "vendor, contractor, supplier, proposer, company, parties, persons", "purchase order, PO, contract, agreement", "city, City of Naples, Naples, agency, owner, requestor, parties", "bid, proposal, response, quote".
- 3. BID EXPENSES:** Bidders shall bear all costs and expenses incurred in developing, preparing, and submitting bids.
- 4. EXECUTION OF PROPOSAL:** Proposal must contain a manual signature of authorized representative in the proposal section. Proposal must be typed or printed in ink. Use of erasable ink is not permitted. All corrections made by proposer to his proposal must be initialed.
- 5. BID FORMATTING:** Vendor should type or electronically enter the information onto its bid submittal to prevent errors in the evaluation. Failure to type or electronically enter the information may result in bid disqualification.
- 6. NO PROPOSAL:** If not submitting a proposal, respond by returning the Statement of No Proposal and explain the reason in the spaces provided. Failure to respond 3 times in succession without justification shall be cause for removal of the supplier's name from the proposal mailing list. NOTE: To qualify as a respondent, proposer must submit a "NO PROPOSAL," and it must be received no later than the stated proposal opening date and hour.
- 7. PROPOSAL OPENING:** Shall be public, on the date and at the time specified on the proposal form. It is the proposer's responsibility to assure that his proposal is delivered at the proper time and place of the proposal opening. Proposals which for any reason are not so delivered will not be considered. Offers by telegram; telephone; or fax are not acceptable. Proposal files may be examined during normal working hours.
- 8. WITHDRAWAL OF PROPOSALS:** Withdrawal of a proposal within sixty (60) days after the opening of proposals is subject to suspension or debarment in accordance with Section 2-668(2) of the City Code.
- 9. PRICES, TERMS and PAYMENT:** Prices shall be proposed if required by this request for proposal and include all packing, handling, shipping charges and delivery

to the destination shown herein. Proposer is encouraged to offer cash discount for prompt invoice payment. Terms of less than 20 days will not be considered.

- A. **TAXES:** The City of Naples does not pay Federal Excise and Sales taxes on direct purchases of tangible personal property. See exemption number on face of purchase order. This exemption does not apply to purchases of tangible personal property made by contractors who use the tangible personal property in the performance of contracts for the improvement of City- owned real property.
 - B. **MISTAKES:** Proposers are expected to examine the specifications, delivery schedule, proposal prices, extensions, and all instructions pertaining to supplies and services. Failure to do so will be at proposer's risk. In case of mistake in extension, the unit price will govern.
 - C. **CONDITION AND PACKAGING:** It is understood and agreed that any item offered or shipped as a result of this proposal shall be a new, current standard production model available at the time of this proposal. All containers shall be suitable for storage or shipment, and all prices shall include standard commercial packaging.
 - D. **SAFETY STANDARDS:** Unless otherwise stipulated in the proposal, all manufactured items and fabricated assemblies shall comply with applicable requirements of Occupational Safety and Health Act and any standards there under.
 - E. **UNDERWRITERS' LABORATORIES:** Unless otherwise stipulated in the proposal, all manufactured items and fabricated assemblies shall carry U.L. approval and re-examination listing where such has been established.
 - F. **PAYMENT:** Payment will be made by the buyer after the items awarded to a vendor have been received, inspected, and found to comply with award specifications, free of damage or defect and properly invoiced. All invoices shall bear the purchase order number. Payment for partial shipments shall not be made unless specified in the proposal. Failure to follow these instructions may result in delay in processing invoices for payment. In addition, the purchase order number must appear on bills of lading, packages, cases, delivery lists and correspondence.
 - G. **CREDIT CARD PAYMENT:** The City of Naples may, at its discretion, use VISA/MASTER card credit network as a payment vehicle for goods and services purchased as a part of this contract. The City of Naples will not accept any additional surcharges (credit card transaction fees) as a result of using the City's credit card for transactions relating to this solicitation.
- 10. DELIVERY:** Unless actual date of delivery is specified (or if specified delivery cannot be met), show number of days required to make delivery after receipt of purchase order in space provided. Delivery time may become a basis for making an award (see Special Conditions). Delivery shall be within the normal working hours of the user, Monday through Friday, unless otherwise specified. Unless otherwise specified, all prices are to be FOB-Destination.
- 11. MANUFACTURERS' NAMES AND APPROVED EQUIVALENTS:** Any manufacturers' names, trade names, brand names, information and/or catalog

numbers listed in a specification are for information and not intended to limit competition. The proposer may offer any brand for which he is an authorized representative, which meets or exceeds the specification for any item(s). If proposals are based on equivalent products, indicate on the proposal form the manufacturer's name and number. Proposer shall submit with his proposal, cuts, sketches, and descriptive literature, and/or complete specifications. Reference to literature submitted with a previous proposal will not satisfy this provision. The proposer shall also explain in detail the reason(s) why the proposed equivalent will meet the specifications and not be considered an exception thereto. Proposals which do not comply with these requirements are subject to rejection. Proposals lacking any written indication of intent to quote an alternate brand will be received and considered in complete compliance with the specifications as listed on the proposal form.

12. SPECIAL CONDITIONS: The Purchasing Department has the authority to issue Special Conditions as required for any solicitation. Any Special Conditions that vary from these General Conditions will take precedence over the General Conditions. The special additions are supplemental and in addition to the General Conditions. To the extent that there is a conflict between the General Conditions and the Special Conditions, the Special Conditions will apply and control to the extent of the conflict.

13. ADDENDA AND INTERPRETATIONS: No interpretations of the meaning of the plans, specifications or other contract documents will be made orally to any bidder. Prospective bidders must request from the Purchasing and Contracts Manager such interpretation in writing. To be considered, such request must be received 10 calendar days prior to the bid opening. Request must reference the date of bid opening, bid title, and bid number. Failure to comply with this condition will result in bidders waiving their rights to dispute the proposal. Any and all interpretations and any supplemental instructions will be in the form of a written addenda which, if issued, will be posted on the City website and DemandStar.com not later than (3) days prior for the opening of bids. Failure of any bidder to receive any such addenda or interpretation shall not relieve any bidder from any obligation under their bid as submitted. All addenda so issued shall become a part of the contract document.

14. CONFLICT OF INTEREST: All proposal awards are subject to Section 2-72 Conflict of Interest, City of Naples Code of Ordinances, which states: *"No public officer or employee shall have or hold any employment or contractual relationship with any business entity or any agency which is subject to the regulation of or is doing business with the city; nor shall an officer or employee have or hold any employment or contractual relationship that will create a continuing or frequently recurring conflict between his private interests and the performance of his public duties or that would impede the full and faithful discharge of his public duties. Any member of the city council or any city officer or employee who willfully violates this section shall be guilty of malfeasance in office or position and shall forfeit his office or position. Violation of this section with the knowledge, express or implied, of the person or corporation contracting with or making a sale to the city shall render the contract or sale voidable by the city manager or the city council."*

15. CONE OF SILENCE: "Cone of Silence" means a prohibition on any

communication regarding a particular Request for Proposals (RFP), Request for Qualifications (RFQ), Invitation to Bid (ITB), or other competitive solicitation between:

Any person who seeks an award therefrom, including a potential vendor or vendor's representative, and

The City Council, City Attorney, and all City employees, and any non-employee appointed to evaluate or recommend selection in such procurement process.

The Cone of Silence shall not apply to communications with the Procurement Official to obtain clarification or information concerning the subject solicitation. Any such contact other than the Procurement Official may be considered grounds for disqualification. The City shall not be responsible for oral interpretations given by any City employee or its representative. For purposes of this section, "vendor's representative" means an employee, partner, director, or officer of a potential vendor, or consultant, lobbyist, or actual or potential subcontractor or sub-consultant of a vendor, or any other individual acting through or on behalf of any person seeking an award.

16. ETHICS REQUIREMENT: As required by Section 2-975(h)(3), except as otherwise prohibited by law, all contracts executed between the City and a vendor shall 1) prohibit the vendor from employing, or offering to employ any compensated public official or city employee who is substantially involved with the regulation, oversight or management of the contract or the transaction of business during the term, and for a period of two years after termination, of the contract; and 2) provide for liquidated damages in favor of the City for violation of this subsection in the amount equal to the greater of: (i) the compensation received by the compensated public official or city employee from the vendor; and (ii) the amount equal to the total of the compensated public official's or City employee's last two years of gross compensation from the City.

17. E-VERIFY REQUIREMENT: All contracts between the vendor and the City shall require the vendor to be obligated to comply with the provisions of Section 448.095, Florida Statutes (2023) "Employment Eligibility," as amended from time to time. This includes, but is not limited to, registration and use of the E-Verify System to verify the work authorization status of all newly hired employees and requiring any and all subcontractors to provide an affidavit to vendor attesting that the subcontractor does not employ, contract with, or subcontract with, an unauthorized alien. The vendor shall require any subcontractor to insert into any subcontracts the requirements of this section and shall be responsible for insuring compliance by all subcontractors. The Vendor shall agree to maintain a copy of such affidavit for the duration of the Agreement. Failure to comply will result in the termination of the Agreement as provided in Section 448.095, Florida Stat. (2023), as amended; and the vendor will not be awarded a public contract for at least one (1) year after the date on which the contract was terminate. Vendor will also be

liable for any additional costs to City incurred because of the termination of the contractor.

The City shall upon a good faith belief that a vendor or its subcontractor has knowingly violated Section 448.09(1), Florida Statutes or the provisions of Section 448.095, Florida Statutes, terminate the contract, which shall not be considered a breach of contract and may be challenged pursuant to Section 448.095(2)(d), Florida Statutes. Vendor acknowledges that upon termination of the contract by the City for a violation of this Section, the vendor may not be awarded a public contract for at least one (1) year and that the Vendor is liable for any additional costs incurred by the City as a result of the termination. Vendor shall provide an affidavit of compliance with the E-Verify Requirement at the time a contract is executed.

18. AWARDS: As the best interest of the City may require, the right is reserved to make award(s) by individual item, group of items, all or none, divide the award or a combination thereof; to reject any and all proposals or waive any minor irregularity or technicality in proposals received.

19. ADDITIONAL QUANTITIES: For a period not exceeding ninety (90) days from the date of acceptance of this offer by the buyer, the right is reserved to acquire additional quantities up to but not exceeding those shown on proposal at the prices proposal in this invitation. If additional quantities are not acceptable, the proposal sheets must be noted "PROPOSAL IS FOR SPECIFIED QUANTITY ONLY." (THIS PARAGRAPH DOES NOT APPLY FOR A TERM CONTRACT.)

20. SERVICE AND WARRANTY: Unless otherwise specified, the proposer shall define any warranty service and replacements that will be provided during and subsequent to this contract. Proposers must explain on an attached sheet to what extent warranty and service facilities are provided.

The City of Naples will not accept any disclaimer of the warranties of merchantability and fitness for a particular purpose for the products offered. Proposals will clearly state any additional warranties and guarantees against defective materials and workmanship. A copy of the complete manufacturer's warranty statement is to be submitted with the proposal.

21. SAMPLES: Samples of items, when called for, must be furnished free of expense, and if not destroyed, may upon request, be returned at the proposer's expense. Each individual sample must be labeled with proposer's name, manufacturer's brand name and number, proposal number and item reference. Request for return of samples shall be accompanied by instructions which include shipping authorization and name of carrier and must be received with your proposal. If instructions are not received within this time, the commodities shall be disposed of by the City of Naples.

22. PROPOSAL PROTESTS: The City of Naples has formal protest procedures that

are available upon request.

- 23. INSPECTION, ACCEPTANCE AND TITLE:** Inspection and acceptance will be at destination unless otherwise provided. Title and risk of loss or damage to all items shall be the responsibility of the contract supplier until accepted by the ordering agency, unless loss or damage results from negligence by the ordering.
- 24. DISPUTES:** In case of any doubt or difference of opinion as to the items to be furnished hereunder, the decision of the buyer shall be final and binding on both parties.
- 25. GOVERNMENTAL RESTRICTIONS:** In the event any governmental restrictions may be imposed which would necessitate alteration of the material, quality, workmanship or performance of the items offered on this proposal prior to their delivery, it shall be the responsibility of the successful proposer to notify the buyer at once, indicating in his letter the specific regulation which required an alteration. The City reserves the right to accept any such alteration, including any price adjustments occasioned thereby, or to cancel the contract at no expense to the City.
- 26. LEGAL REQUIREMENTS:** Applicable provision of all Federal, State, county and local laws, and of all ordinances, rules, and regulations shall govern development submittal and evaluation of all proposals received in response hereto and shall govern any and all claims and disputes which may arise between person(s) submitting a proposal response hereto and the City of Naples by and through its officers, employees and authorized representatives, or any other person, natural or otherwise; and lack of knowledge by any proposer shall not constitute a cognizable defense against the legal effect thereof.
- 27. PATENTS AND ROYALTIES:** The proposer, without exception, shall indemnify and save harmless the City of Naples and its employees from liability of any nature or kind, including cost and expenses for or on account of any copyrighted, patented, or unpatented invention, process, or article manufactured or used in the performance of the contract, including its use by the City of Naples. If the proposer uses any design, device, or materials covered by letters, patent or copyright, it is mutually agreed and understood without exception that the proposal prices shall include all royalties or cost arising from the use of such design, device, or materials in any way involved in the work.
- 28. ADVERTISING:** In submitting a proposal, proposer agrees not to use the results there from as a part of any commercial advertising.
- 29. ASSIGNMENT:** Any Purchase Order issued pursuant to this proposal invitation and the monies which may become due hereunder are not assignable except with the prior written approval of the buyer.
- 30. LIABILITY:** The supplier shall hold and save the City of Naples, its officers, agents, and employees harmless from liability of any kind in the performance of

this contract.

- 31. PUBLIC ENTITY CRIMES:** A person or affiliate who has been placed on the convicted vendor list following a conviction for a public entity crime may not submit a proposal on a contract to provide any goods or services to a public entity, may not submit a proposal on a contract with a public entity for the construction or repair of a public building or public work, may not submit proposals on leases of real property to a public entity, may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity, and may not transact business with any public entity in excess of the threshold amount provided in Section 287.017, for CATEGORY TWO for a period of 36 months from the date of being placed on the convicted vendorlist.
- 32. DISCRIMINATION:** Pursuant to Subsection 287.134(2)(a), F.S., “an entity or affiliate who has been placed on the discriminatory vendor list may not submit a bid, proposal or reply on a contract to provide any goods or services to a public entity; may not submit a bid, proposal, or reply on a contract with a public entity for the construction or repair of a public building or public work; may not submit bids, proposals or replies on leases of real property to a public entity; may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity; and may not transact business with any public entity”.
- 33. COUNTY TAXES:** No proposal shall be accepted from and no contract will be awarded to any person, firm or corporation that is in arrears to the government of Collier County, Florida.
- 34. OFFER EXTENDED TO OTHER GOVERNMENTAL ENTITIES:** The City of Naples encourages and agrees to the successful proposer/proposer extending the pricing, terms and conditions of this solicitation or resultant contract to other governmental entities at the discretion of the successful proposer/proposer.

IF THIS PROPOSAL IS FOR A TERM CONTRACT, THE FOLLOWING CONDITIONS SHALL ALSO APPLY

- 35. ELIGIBLE USERS:** All departments of the City of Naples are eligible to use this term contract. Such purchases shall be exempt from the competitive proposal requirements otherwise applying to their purchases.
- 36. PRICE ADJUSTMENTS:** Any price decrease effectuated during the contract period by reason of market change shall be passed on to City of Naples. Price increases are not acceptable.
- 37. CANCELLATION:** All contract obligations shall prevail for at least one hundred eighty (180) days after effective date of contract. After that period, for the protection of both parties, this contract may be cancelled in whole or in part by either party by giving thirty (30) days prior written notice to the other party.

38. RENEWAL: Contract will be in-place for a three (3) year term with an optional two (2) one (1) year renewals, if mutually agreed upon by the CITY and CONTRACTOR. Pursuant to the City of Naples Code of Ordinances, Sec.2-667(7)(e), the term of this contract may be extended by the parties for no more than two years. Each renewal or extension shall be automatically extended for automatic and successive additional terms, unless either party gives written notice to the other not fewer than ninety (90) days prior to the expiration of the then current term. It is recognized that the terms “renewal” and “extension” once had a distinct meaning in the law; however, the intent of this section is that no contract whether continued by a renewal, extension, or a combination of the two, will result in a term of more than three years plus two years, for a total of five years maximum without City Council approval.

39. ABNORMAL QUANTITIES: While it is not anticipated, should any unusual or abnormal requirements arise, the City reserves the right to solicit separate proposals thereon.

40. FISCAL NON-FUNDING CLAUSE: In the event sufficient funds are not budgeted for a new fiscal period, the City shall notify the contractor of such occurrence and the contract shall terminate on the last day of the current fiscal year without penalty or expense to the City.

IF THIS PROPOSAL IS FOR PERFORMING A SERVICE, THE FOLLOWING CONDITIONS SHALL ALSO APPLY

41. ALTERNATIVE PROPOSALS: Proposers offering service delivery methods other than those permitted by the scope of work may submit a separate envelope clearly marked "ALTERNATIVE PROPOSAL". Alternative proposals will be deemed non-responsive and will not be considered for award. All such responses will, however, be examined prior to award. Such examination may result in cancellation of all proposals received to permit rewriting the scope of work to include the alternative method, or the alternative method may be considered for future requirements of the City of Naples.

42. ANTITRUST: By entering into a contract, the contractor conveys, sells, assigns and transfers to the City of Naples all rights, titles and interest it may now have or hereafter acquire under the antitrust laws of the United States and the State of Florida that relate to the particular goods or services purchased or acquired by the City of Naples under said contract.

43. PROPOSER INVESTIGATIONS: Before submitting a proposal, each proposer shall make all investigations and examinations necessary to ascertain all site conditions and requirements affecting the full performance of the contract and

to verify any representations made by the City of Naples upon which the proposer will rely. If the proposer receives an award as a result of its proposal submission, failure to have made such investigations and examinations will in no way relieve the proposer from its obligation to comply in every detail with all provisions and requirements of the contract documents, nor will a plea of ignorance of such conditions and requirements be accepted as a basis for any claim whatsoever by the contractor for additional compensation.

44. CERTIFICATES AND LICENSES: The Contractor, at time of proposal, shall possess the correct occupational licenses, all professional licenses or other authorizations necessary to carry out and perform the work required by the City of Naples and Collier County for this project pursuant to all applicable Federal, State and Local Laws, Statutes, Ordinances, and rules and regulations of any kind.

45. CHANGE IN SCOPE OF WORK: The City of Naples may order changes in the work consisting of additions, deletions or other revisions within the general scope of the contract. No claims may be made by the contractor that the scope of the project or of the contractor's services has been changed, requiring changes to the amount of compensation to the contractor or other adjustments to the contract unless such changes or adjustments have been made by written amendment to the contract signed by the City of Naples and the contractor. If the contractor believes that any particular work is not within the scope of the project, is a material change, or will otherwise require more compensation to the contractor, the contractor must immediately notify the City in writing of this belief. If the City believes that the particular work is within the scope of the contract as written, the contractor will be ordered to and shall continue with the work as changed and at the cost stated for the work within the scope.

46. CHANGE ORDERS: The City may, by field directive, authorize minor variations from the requirements of the contract documents, which do not involve an adjustment in the contract price or the contract time and are consistent with the overall intent of the contract documents. Supplemental agreements, in the form of "change orders" shall be used to clarify the plans and specifications, to provide for unforeseen work or alterations in plans, to change the limits of construction to meet field conditions, to provide a safe and functional connection to an existing facility, to make the project functionally operational in accordance with the intent of the original contract, or to adjust the contract price or the contract time requirements. The City of Naples will not pay more than a total of 10% on markup and overhead. Any supplemental agreement shall be approved by the City Manager, contractor and the architect/engineer, if applicable, prior to the commencement of the modified work. The City Manager may only approve contract change orders not exceeding 25 percent of the original contract that were originally approved by City Council. Contracts originally approved at \$50,000.00 or less will be limited to an amount that does not exceed \$75,000.00 for a change order or modification. (City Code Sec.2- 667.(7)(a)(b).

The City reserves the right to make, at any time prior to or during the progress of the work, increases or decreases in the quantities of work as may be found necessary or desirable by the City. Compensation for changes in quantities shall be at the bid unit price for the specific item of work with no additional charges allowed for the change in quantity.

All unit prices for items of work in the original contract shall be considered all-inclusive of expenses necessary to accomplish the work regardless of the unit of measure (e.g. LS, LF, CY, SY, TN, etc.) including but not limited to:

1. Material
2. Delivery
3. Direct Labor
4. Taxes
5. Rental rates
6. Fringe Benefits
7. Overhead
8. Profit
9. Markup

A change in quantities whether greater than or lower than the original bid quantity shall be treated as if the new quantity was part of the original quantity of work with respect to unit value. Upon approval of changed quantities the quantities shall be adjusted on the schedule of values to reflect the new total quantity of each item of work. Each proposal for change order shall list both the reduction in quantity of deleted work and increased quantity of added work. The City of Naples will not pay more than a total of 10% on markup and overhead when establishing a negotiated fee for items not listed by unit price.

47. AWARDED CONTRACT: An awarded contract with hourly rates will determine any overtime that is authorized by the City and its Project Manager. Any authorized overtime rates will be based on the standard 1.5 time the indicated hourly rate. This multiplier will be used on any overtime hours being charged that have been mutually agreed upon by the CITY and CONTRACTOR.

48. RATE ADJUSTMENTS: Rate Adjustments: Any adjustment to an awarded agreement that contains equipment and labor rates in the agreement shall be made in one or more of the following ways:

1. By agreement on a fixed price adjustment before commencement of the pertinent performance or as soon thereafter as practicable;
2. By unit prices specified in the Contract or subsequently agreed upon;
3. By the costs attributable to the event or situation covered by the provision, plus appropriate profit or fee, all as specified in the Contract or subsequently agreed upon;
4. In such other manner as the parties may mutually agree; or
5. In the absence of agreement between the parties, by a unilateral

determination by the Agency procurement officer of the costs attributable to the event or situation covered by the provision, plus appropriate profit or fee, all as computed by the Agency procurement officer in accordance with generally accepted accounting principles.

- 49. CONTRACTOR PERSONNEL:** The City of Naples shall, throughout the life of the contract, have the right of reasonable rejection and approval of staff or subcontractors assigned to the work by the contractor. If the City reasonably rejects staff or subcontractors, the contractor must provide replacement staff or subcontractors satisfactory to the City in a timely manner and at no additional cost to the City. The day- to-day supervision and control of the contractor's employees and sub- contractors is the responsibility solely of the contractor.
- 50. COST REIMBURSEMENT:** The contractor agrees that all incidental costs, including allowances for profit and tools of the trade, must be included in the proposal rates. If an arrangement is made between the contractor and the City to reimburse the contractor for the cost of materials provided in the performance of the work, the contractor shall be reimbursed in the following manner: The City shall reimburse the contractor on completion and acceptance of each assigned job, only for those materials actually used in the performance of the work that is supported by invoices issued by the suppliers of the contractor describing the quantity and cost of the materials purchased. No surcharge shall be added to the supplier's invoices or included in the contractor's invoice submitted to the City that would increase the dollar amount indicated on the supplier's invoice for the materials purchased for the assigned job.
- 51. EXCEPTIONS:** Proposers taking exception to any part or section of the solicitation shall indicate such exceptions on the proposal form. Failure to indicate any exception will be interpreted as the proposer's intent to comply fully with the requirements as written. Conditional or qualified proposals, unless specifically allowed, shall be subject to rejection in whole or in part.
- 52. FAILURE TO DELIVER:** In the event of the contractor to fail to deliver services in accordance with the contract terms and conditions, the City, after due oral or written notice, may procure the services from other sources and hold the contractor responsible for any resulting purchase and administrative costs. This remedy shall be in addition to any other remedies that the City may have.
- 53. FAILURE TO ENFORCE:** Failure by the City at any time to enforce the provisions of the contract shall not be construed as a waiver of any such provisions. Such failure to enforce shall not affect the validity of the contract or any part thereof or the right of the City to enforce any provision at any time in accordance with its terms.
- 54. FORCE MAJEURE:** The contractor shall not be held responsible for failure to

perform the duties and responsibilities imposed by the contract due to legal strikes, fires, riots, rebellions and acts of God beyond the control of the contractor, unless otherwise specified in the contract.

55. INDEPENDENT CONTRACTOR: The contractor shall be legally considered an independent contractor and neither the contractor nor its employees shall, under any circumstances, be considered servants or agents of the City of Naples and the City of Naples shall be at no time legally responsible for any negligence or any wrongdoing by the contractor, its servants or agents. The City of Naples shall not withhold from the contract payments to the contractor any federal income taxes, Social Security tax, or any other amounts for benefits to the contractor. Further, the City shall not provide to the contractor any insurance coverage or other benefits, including Workers' Compensation normally provided by the City for its employees.

56. ORAL STATEMENTS: No oral statement of any person shall modify or otherwise affect the terms, conditions or specifications stated in this contract. All modifications to the contract must be made in writing by the City of Naples.

57. QUALIFICATIONS OF PROPOSERS: The proposer may be required, before the award of any contract, to show to the complete satisfaction of the City of Naples that it has the necessary facilities, ability, and financial resources to provide the service specified therein in a satisfactory manner. The proposer may also be required to give a past history and references in order to satisfy the City in regard to the proposer's qualifications. The City may make reasonable investigations deemed necessary and proper to determine the ability of the proposer to perform the work, and the proposer shall furnish to the City all information for this purpose that may be requested. The

City reserves the right to reject any proposal if the evidence submitted by, or investigation of, the proposer fails to satisfy the City that the proposer is properly qualified to carry out the obligations of the contract and to complete the work described therein. Evaluation of the proposer's qualifications shall include:

- > The ability, capacity, skill and financial resources to perform the work or service.
- > The ability to perform the work service promptly or within the time specified, without delay.
- > The character, integrity, reputation, judgment, experience, and efficiency of the proposer.
- > The quality of performance of previous contracts or services.

58. QUALITY CONTROL: The contractor shall institute and maintain throughout the contract period a properly documented quality control program designed to ensure that the services are provided at all times and in all respects in accordance with the contract. The program shall include providing daily supervision and conducting frequent inspections of the contractor's staff and ensuring that accurate records are maintained describing the disposition of all complaints. The records so created shall be open to inspection by the City.

59. RESPONSIBLE VENDOR DETERMINATION: Respondent is hereby notified that Section 287.05701, Florida Statutes, requires that the City may not request documentation of or consider a vendor's social, political, or ideological interests when determining if the vendor is a responsible vendor.

60. RECOVERY OF MONEY: Whenever, under the contract, any sum of money shall be recoverable from or payable by the contractor to the City, the same amount may be deducted from any sum due to the contractor under the contract or under any other contract between the contractor and the City. The rights of the City are in addition and without prejudice to any other right the City may have to claim the amount of any loss or damage suffered by the City on account of the acts or omissions of the contractor.

61. REQUIREMENTS CONTRACT: During the period of the contract, the contractor shall provide all the services described in the contract. The contractor understands and agrees that this is a requirements contract and that the City shall have no obligation to the contractor if no services are required. Any quantities that are included in the scope of work reflect the current expectations of the City for the period of the contract. The amount is only an estimate and the contractor understands and agrees that the City is under no obligation to the contractor to buy any amount of services as a result of having provided this estimate or of having any typical or measurable requirement in the past. The contractor further understands and agrees that the City may require services in excess of the estimated annual contract amount and that the quantity actually used whether in excess of, or less than, the estimated annual contract amount and that the quantity actually used shall not give rise to any claim for compensation other than the total of the unit prices in the contract for the quantity actually used.

62. TERMINATION FOR CONVENIENCE: The performance of work under the contract may be terminated by the City in whole or in part whenever the City determines that termination is in the City's best interest. Any such termination shall be effected by the delivery to the contractor of a written notice of termination of at least seven (7) days before the date of termination, specifying the extent to which performance of the work under the contract is terminated and the date upon which such termination becomes effective. After receipt of a notice of termination, except as otherwise directed, the contractor shall stop work on the date of the receipt of the notice or other date specified in the notice; place no further orders or subcontracts for materials, services or facilities except as necessary for completion of such portion of the work not terminated; terminate all vendors and subcontracts; and settle all outstanding liabilities and claims.

63. TERMINATION FOR DEFAULT: The City of Naples reserves the right to terminate the contract if the City determines that the contractor has failed to perform satisfactorily the work required, as determined by the City. In the event the City decides to terminate the contract for failure to perform satisfactorily, the City shall give to the contractor at least seven (7) days written notice before the

termination takes effect. The seven-day period will begin upon the mailing of notice by the City. If the contractor fails to cure the default within the seven (7) days specified in the notice and the contract is terminated for failure to perform satisfactorily, the contractor shall be entitled to receive compensation for all reasonable, allocable and allowable contract services satisfactorily performed by the contractor up to the date of termination that were accepted by the City prior to the termination. In the event the City terminates the contract because of the default of the contractor, the contractor shall be liable for all excess costs that the City is required to expend to complete the work under contract.

64. STATE AND FEDERAL EMPLOYMENT LAWS: Contractors providing service to the City are required to comply with all state and federal employment laws. This includes, but is not limited to, laws resulting from the Immigration and Reform and Control Act of 1986, wherein all employers are required to verify the identity and employment eligibility of all employees. The Department of Homeland Security, U.S. Citizenship and Immigration Services require employees and employers to complete Form I-9 and the employer must examine evidence of identity and employment eligibility within three business days of the date employment begins. Non-compliant contractors will be subject to contract sanctions, up to and including contract termination.

65. The resulting contract will commence no earlier than April 1, 2024 and will be in-place for a one (1) year term with an optional four (4) one (1) year renewals, if mutually agreed upon by the CITY and CONTRACTOR. Pursuant to the City of Naples Code of Ordinances, Sec.2-667(7)(e), the term of this contract may be extended by the parties for no more than four (4) years. Each renewal or extension shall be automatically extended for automatic and successive additional terms unless either party gives written notice to the other not fewer than ninety (90) days prior to the expiration of the then-current term.

Should changes in operations occur that may require an alternate disposal/processing location, the City reserves the right to negotiate such changes with the awarded contractor in order to account for cost ramifications that may result from greater (or less) hauling distances. The methodology and logic used for negotiations for rate changes will be established and calculated on a case-by-case basis and will require City Manager approval.

B. PROHIBITION OF CONTACT

The Contractor shall furnish to the City a Payment and Performance bond executed by a surety company licensed to do business in the State of Florida and/or irrevocable letter of credit issued by a bank acceptable by the City to ensure the faithful performance of the Agreement and all obligations arising hereunder in the amount of the value of one contractual year of the contract required to complete the annual Scope of Services provided herein. The clean irrevocable letter of credit or bonds provided hereunder may be substituted for each other upon approval from the City of Naples. The form of the bonds, or letter of credit and the Surety Company shall be acceptable to the City, its City Attorney and the Contract Administrator and shall be maintained during the term of this Agreement. The bonds shall be endorsed to show The City of Naples, a political subdivision of the State of Florida, to provide that bonds shall not be canceled, limited, or non-renewable until after thirty (30) days written notice has been given to the City. A current payment and performance bond or its irrevocable equivalent letter of credit must be on file with the City that evidences the required coverage of each contractual year of the Contract.

J. ANNUAL PRICE ADJUSTMENTS

The unit prices for all chemicals contained within this solicitation shall remain the same through the first year of the Agreement. Beginning April 1, 2024, and each April 1 for the remaining term of the Agreement, the rate shall be adjusted, if requested, in writing, by the Contractor. If a rate adjustment is requested, the adjustment, per annum will be as follows: The rate shall be adjusted based on the percentage change in the Consumer Price Index, South Urban Region, All Items – All Urban Areas between the month of August in the previous year and the month of August in the current year. The total adjustment to the rate in any given year shall not exceed five percent (5%) of the previous year's rate.

The CPI will be the Consumer Price Index for the South Urban Region, All Items - All Urban Wage Earners and Clerical Workers, published by the United States Department of Labor, Department of Labor Statistics.

If the CPI is discontinued or substantially altered, the City may select another relevant price index published by the United States Government or by a reputable publisher of financial and economic indices.

The Contractor may petition the city for an additional rate adjustment resulting from a change in law or economic hardship (example: exceptional material price increases). The Contractor's request shall contain substantial proof and justification to support the need for the rate adjustment. The city may request from the Contractor such further information as may be reasonably necessary in making its determination. Within sixty (60) calendar days of receipt of the request and all other additional information required by the City, the Department Director shall determine the fairness of the request and shall make a recommendation to the City Manager. Any rate increase per product and final acceptance of said increase will be determined by the city. Adjusted rates shall become effective upon approval by the City Manager.

Example. Article 20 of the U.S.-China income tax treaty allows an exemption from tax for scholarship income received by a Chinese student temporarily present in the United States. Under U.S. law, this student will become a resident alien for tax purposes if his or her stay in the United States exceeds 5 calendar years. However, paragraph 2 of the first Protocol to the U.S.-China treaty (dated April 30, 1984) allows the provisions of Article 20 to continue to apply even after the Chinese student becomes a resident alien of the United States. A Chinese student who qualifies for this exception (under paragraph 2 of the first protocol) and is relying on this exception to claim an exemption from tax on his or her scholarship or fellowship income would attach to Form W-9 a statement that includes the information described above to support that exemption.

If you are a nonresident alien or a foreign entity, give the requester the appropriate completed Form W-8 or Form 8233.

Backup Withholding

What is backup withholding? Persons making certain payments to you must under certain conditions withhold and pay to the IRS 24% of such payments. This is called "backup withholding." Payments that may be subject to backup withholding include interest, tax-exempt interest, dividends, broker and barter exchange transactions, rents, royalties, nonemployee pay, payments made in settlement of payment card and third party network transactions, and certain payments from fishing boat operators. Real estate transactions are not subject to backup withholding.

You will not be subject to backup withholding on payments you receive if you give the requester your correct TIN, make the proper certifications, and report all your taxable interest and dividends on your tax return.

PROJECT REQUIREMENTS AND SPECIFICATIONS

A. INTRODUCTION

The City of Naples (City) is seeking sealed bids for a contractor(s) to provide hauling services (the Service) for recyclable materials staged from a central location to an approved Material Recycling/Recovery Facility (MRF) which is located in Lee County at 10550 Buckingham Road, Fort Myers, FL 33905. The City's intention is to enter into a single agreement with one vendor to provide the hauling service described in this Invitation-To-Bid. The Contractor(s) will be responsible for the complete delivery of the required services.

B. BACKGROUND

The City encompasses 16.45 square miles with single family homes and multi-family households who receive single stream recycling collection service provided by the City. The City collects single stream recycle material via 65-gallon carts placed by the curbside and transports the collected material to the City's recycle transfer facility located at 2600 Corporate Flight Drive, Naples, FL 34104. The material is then loaded into a 100 cubic yard "walking floor" tractor trailers and is transported to the Lee County MRF located in Ft. Myers for processing. The City's single stream collection, hauling, and processing services have not been fundamentally altered for the past 13 years.

The City's existing Interlocal Agreement with Lee County for processing services will expire on April 2025. The Agreement does include a one-year extension for the potential to extend the Agreement through April 2026. Due to future capacity concerns, Lee County has indicated that they may no longer be able to accept the City's recyclable material for processing after April 2025.

The requested services outlined within this bid shall begin April 1, 2024. The contractor shall provide hauling trailers to receive the single stream recyclables from the City of Naples Recycle Transfer Facility located at 2600 Corporate Flight Drive, Naples, FL 34104. The recyclables are to be transported to the Lee County Material Recycling/Recovery Facility (MRF) which is located at 10550 Buckingham Road, Fort Myers, FL 33905. The successful bidder is to provide the necessary equipment to haul and transport all recyclable materials to the MFR.

The quantity of recycle material collected by the City of Naples has averaged an estimated 3,200 tons per year. The material is collected on a weekly basis and includes mixed glass.

Upon the declaration of the low bidder(s) meeting specifications, the City is seeking an initial contract that will cover a one (1) year term that will be subject to approval by the

City's Council. The City shall reserve the right to re-bid these services at the end of any contract period or provide the option for four (4) additional one (1) year renewal periods (potential 5-year contract).

C. DEFINITIONS FOR SPECIFICATIONS

The specifications contained in this section are intended to describe the services and/or work to be provided by the Successful Proposer/Contractor(s). The following words and expressions (or pronouns) shall, wherever they appear in this Invitation-To-Bid and the Contract Documents, be construed as follows unless a different meaning is clear from the context:

- “Agreement” shall mean the specific Bid Data, Instructions to Bidders, General Terms and Conditions, Special Terms and Conditions, Specifications, all Addenda issued, the Contractor’s Proposal, the Agreement, and all the attached documents identified in this Invitation-To-Bid for Recycle Material Hauling and Processing Services.
- “Hauling Vehicle” shall mean any vehicle used by the Contractor to provide hauling/transport services.
- “Project Manager” shall mean the City Utilities Department representative responsible for the oversight of the Contractor.
- “Contractor” shall mean any Vendor awarded to service this Program by the City Council for the right to haul and process recycle material generated by the City.
- “Designated Material Recycle/Recovery Facility (MRF)” shall mean the City-approved facility(s) where the recycle material collected pursuant to this Agreement shall be delivered. Currently the designated facility is the Lee County Material Recycling/Recovery Facility (MRF) which is located at 10550 Buckingham Road, Fort Myers, FL 33905.
- “General Manager” shall mean the Contractor’s representative appointed by the Contractor to be responsible for overseeing and implementing the Contractor’s performance under the Agreement.
- “Hazardous Waste” shall mean solid waste, or a combination of solid wastes, which, because of its quantity, concentration, or physical, chemical, or infectious characteristics, may cause, or significantly contribute to, an increase in mortality or an increase in serious irreversible or incapacitating reversible illness or may pose a substantial present or potential hazard to human health or the environment when improperly transported, disposed of, stored, treated, or otherwise managed. The term does not include human remains that are disposed of by persons licensed under F.S. Chapter 407.
- “Holidays” shall mean New Year’s Day, Fourth of July, Thanksgiving Day, and Christmas Day.
- “Missed Collection” shall mean a collection that does not occur before 5:00 p.m. on the regularly scheduled collection Day, or in the case of a Special Collection, a

collection which does not occur as agreed to between the Customer and the Contractor.

- “Program” shall represent the legal arrangement between the City and the Contractor(s) to transport and haul all Recycle Materials collected and staged at the City’s Recycle Transfer Facility as directed by the City.
- “Solid Waste” shall mean garbage, refuse, and other discarded solid materials, including solid waste materials resulting from industrial, commercial, or agricultural operations, governmental operations, and from community activities, but does not include solids or dissolved materials in domestic sewage or other significant pollutants in water resources, such as silt, dissolved or suspended solids in industrial wastewater effluents, dissolved materials in irrigation return flows, other common water pollutants, or any byproducts, the sale or reuse of which is intended by the Person from whose process they resulted.
- “Ton” shall mean a unit weight equal to 2,000 pounds.
- “Recycle Material” shall mean glass, aluminum, metal, plastic and paper
 - Glass – Soda bottles, beer bottles, liquor and wine bottles, glass jars, any other clear, brown, or green glass bottles.
 - Aluminum – Soda and beer cans, aluminum pie pans.
 - Metal – Food cans including soup, fruit, vegetable, juice, pet food and tuna cans.
 - Plastic – Plastic containers marked No. 1-7 including water bottles, milk jugs, detergent & bleach bottles, soda bottles, shampoo bottles, butter or spread tubs.
 - Paper - Newspaper, magazines, paperback & hardcover books, brown white colored paper bags, phone books, junk mail, catalogs, office and computer paper, corrugated cardboard (moving boxes), cardboard (cereal, cracker, pasta, shoe, gift, pizza) boxes.

D. SCOPE OF WORK/TECHNICAL SPECIFICATIONS – HAULING AND TRANSPORT OF RECYCABLE MATERIAL

1. Basic Overview of Scope of Services

To provide hauling and transport services for recycle material generated within the City of Naples.

The Contractor shall provide all labor, materials, equipment, skills, tools, machinery, supervision, facilities and other services to provide the Services required:

- a) Contractor shall provide necessary equipment to haul and transport recyclable materials from central collection point to the MRF – Lee County.

- b) Contractor shall provide consistent and responsible service and have the flexibility to adjust service schedules, trailer or container sizes, or number of trailers to containers to meet demands of the City's Recycle Program.
- c) Services shall be provided during normal operating hours of the City and its recyclable materials processor. The City will work with the Contractor to accommodate changes due to inclement weather and holidays.
- d) Contractor shall ensure that all federal, state and local permit and licensing requirements are maintained throughout the life of the contract. License and permits shall be included with their response to the Invitation to Bid.
- e) Ownership of the equipment and maintenance of equipment is the responsibility of the Contractor. Equipment shall be kept in proper working order and have an aesthetically pleasing appearance.
- f) Contractor is required to provide all necessary signage on any trailers or containers.
- g) Equipment is required to go across the scales upon arriving empty and exiting with recyclables to delivery to the processor. The recyclables shall be weighed again upon arrival at the MRF – Single Stream Recyclers LLC.
- h) Clean up of the collection area shall be the responsibility of the City. The City shall provide all loading of the recyclable material in the Contractor's trailers and/or containers.
- i) The Contractor must meet all federal, state, county, and City laws, rules and regulations in effect on the date of the execution, delivery and throughout the life of the contract. The bidder shall secure all necessary licenses, permits and certificates as required by law.
- j) The Contractor further agrees to indemnify and hold harmless the City and its officers, agents and employees from all claims, damages, losses and expense arising out of or resulting from the performance of the Contractor.
- k) The Contractor shall not sublet, assign, transfer, or in any way give to any others, any portion of work considered under this agreement except with the written approval of the City.
- l) A report shall be provided each month to the City illustrating the total tonnage of recyclable material transported and hauled to the MRF – Lee County.

2. Ownership of Recyclable Material

The City shall hold title and ownership to all collected recyclable materials collected by the Contractor pursuant to the Agreement until such waste is delivered to MRF – Lee County.

3. Recycle Material Hauling and Transporting Service

Recyclable material, with no quantity limit, shall be loaded and collected daily from the central collection point located at 2600 Corporate Flight Drive, Naples, FL 34104 and hauled to an approved MRF located at the Lee County Material Recycling/Recovery Facility (MRF) which is located at 10550 Buckingham Road, Fort Myers, FL 33905. At no time should the sorting floor of the City’s transfer facility exceed 50% capacity. It shall be the contractor’s responsibility to continually provide hauling trailers for recyclable material to be loaded and hauled off site. Once a collection trailer is loaded, the Contractor shall be responsible for transporting the trailer to the approved MFR within 24 hours of the trailer being loaded.

The Contractor shall transport all collected recyclable material to the Lee County MRF.

4. Hours and Days of Collection

Recycle material loading and collection shall take place between 7:00 a.m. and 5:00 p.m., Monday through Friday, except for City-designated holidays to include: New Year’s Day, Fourth of July, Thanksgiving, and Christmas. Make up days are required and may include Saturdays as scheduled by the Project Manager.

5. Contractor-Provided Transport Trailer and Containers

The Contractor shall provide adequate transport trailers and/or containers to effectively and efficiently remove all recycle material that may be generated at the City’s Recycle Transfer Facility within a 24-hour period. The City currently generates an estimated 21 tons of material per day during peak season and generates an estimated 10 tons per day during non-season.

6. Contractor’s Relationship with the City

The Contractor shall cooperate with the City in every reasonable way to facilitate the successful completion of the Service contemplated in the Agreement. The City shall have twenty-four (24) hour access to the Contractor’s General Manager or designee.

To promote the highest level of customer service, the Project Manager may meet monthly with the Contractor for the purpose of ensuring that the Agreement, Solid Waste Ordinances, and applicable law are being interpreted correctly; and addressing any problem the Contractor may be experiencing while performing the Program responsibilities. The City reserves the right to increase the frequency of these meetings as needed.

7. Personnel

The Contractor shall use competent, qualified, sober personnel to provide the Services required by the Agreement. The Contractor shall devote sufficient personnel, time, and attention to its operations under the Agreement to ensure that its performance will be satisfactory to the City.

The Contractor shall appoint a General Manager prior to the commencement of the Services, and that person shall be the primary point of official contact on behalf of the Contractor for all technical and administrative matters pertaining to the Agreement.

All Contractor personnel shall be furnished with and wear company uniform shirts that identify him or her as an employee with the company logo and their first name.

All Contractor personnel shall always maintain a courteous and respectful attitude toward the public and City employees. The Contractor shall instruct its employees to avoid loud or profane language during the performance of their duties. Contractor's employees shall not conduct themselves in a negligent, disorderly, or dishonest manner.

The Project Manager reserves the right to request removal of any Contractor personnel assigned to the City's work for reasonable cause such as discourteous behavior to customers or City employees. Such request shall be addressed in writing to the Contractor's General Manager.

8. Employee Training and Licenses

All of the Contractor's employees shall be qualified and appropriately trained for the tasks assigned to them. The Contractor shall provide refresher courses and additional training to its employees, as needed, to ensure compliance with the requirements of the Agreement and all applicable law. The City has the right to review the Contractor's training records.

At all times when operating vehicles or equipment pursuant to the Agreement, the Contractor's employees shall carry a valid Florida driver's license for the type of vehicle or equipment being operated.

9. Contractor's Safety Program

The Contractor shall develop, implement, and maintain a safety plan for all its operations under the Agreement. The safety plan shall comply with the requirements in American National Standards Institute (ANSI) standards for Solid Waste collections operations and equipment, Occupational Safety and Health Administration (OSHA), and all other applicable laws. A copy of the safety plan shall be provided to the Project Manager upon request.

The Contractor shall provide routine safety training to all its employees, in compliance with ANSI, OSHA, and all other applicable law. Documentation of the

Contractor's training programs, and the successful training of each employee, shall be maintained on file and shall be provided to the Project Manager upon request.

A written procedure shall be established for the immediate removal to a hospital or a doctor's care of any employee or other person that is injured and requires medical assistance during the execution of the Agreement. Any injury sustained by a Contractor employee while on the job, including OSHA recordable injuries, shall be reported to the Project Manager immediately.

10. Office Requirements

The Contractor shall maintain an office within Collier County or Lee County. The office shall remain open for business from 7:00 a.m. to 5:00 p.m., Monday through Friday.

The Contractor's office shall be equipped with adequate and appropriate personnel and equipment to document and timely respond to all inquiries, issues, and complaints. The Contractor's office staff shall be familiar with the City and the Contractor's obligations under the Agreement.

The Contractor shall provide either an answering machine or voice mail service during non-office hours for calls. During office hours, these services must be monitored regularly, so that the Contractor can respond to any message within sixty (60) minutes. During non-office hours, City inquiries shall be recorded and answered no later than noon the following business day.

The Contractor's office shall be equipped with a two-way communication system that can be used to promptly contact the General Manager and all transport vehicle drivers.

The Contractor shall establish a process for receiving and handling emergency calls, both during and after normal operating hours.

11. Customer Service Standards

The Contractor shall be responsible for providing the highest quality service to the City under the provisions of the Agreement.

The Contractor shall resolve all complaints as expeditiously as possible. The Contractor shall take whatever steps are necessary to remedy the cause of a complaint within twenty-four (24) hours after receiving a complaint from the Project Manager. The Contractor may request, and the Project Manager may grant in writing, additional time to remedy a complaint when necessary.

Dispute Resolution Process

- The Contractor shall promptly notify the Project Manager whenever assistance is needed to resolve a dispute between the City, material processor and the Contractor, including but not limited to, disputes concerning the proper interpretation and implementation of the Agreement

and City Code. The Contractor shall notify the Project Manager about any disputes with a material processor that the Contractor has not been able to resolve within twenty-four (24) hours after receiving the complaint.

- The Project Manager shall promptly evaluate the facts concerning such disputes and shall make a fair and impartial determination about such matters.
- The Project Manager shall notify the Contractor in writing concerning the Project Manager's decision about the disputed issues. The Contractor and customer shall have three (3) Days to comply with the Project Manager's decision or, in the alternative, provide the Project Manager with a written request for the dispute to be reviewed by the Utilities Department Director (Director).
- If a request is filed, the Director shall review the facts concerning the dispute within fifteen (15) Days from receipt of the request for review. The Director may confirm, in whole or in part, with the Project Manager's findings; grant relief to the Contractor; or take whatever other action the Department Director deems necessary and appropriate. The Department Director's decision shall be final and non-appealable.

12. Protection of Private and Public Property

The Contractor acknowledges that the loading and collection points are property of the City of Naples. Therefore, attention shall be given to the location of the transfer facility's infrastructure, water meters, transformers, guy wires, utility poles, and irrigation structures. Authorization to use the facility does not abrogate the Contractor's responsibility to exercise caution in relationship to the property of the City of Naples.

The Contractor shall preserve from damage all property encountered at the loading and collection point and delivery location. Wherever property is damaged due to the activities of the Contractor, it shall be restored to its original condition by the Contractor at its own expense. Any type of damage to public or private property shall be reported to the Project Manager immediately.

13. Vehicle and Collection Equipment

General Requirements

All transport vehicles, trailers, containers and equipment operated by the Contractor shall be clearly marked with the name of the Contractor and telephone number.

All vehicles shall be neat in appearance every day and be mechanically well maintained and licensed in the State of Florida. The City, at its discretion, may request that a vehicle be removed from service if it does not meet the aesthetic requirements.

The Contractor shall monitor, maintain and repair its transport vehicles and equipment, at a minimum, in compliance with the manufacturer's recommendations. Oil/hydraulic systems shall always be kept in good condition to prevent spills and leaks. The Contractor shall keep all transport vehicles and equipment cleaned and washed, as necessary, to minimize the potential for odors and nuisance conditions.

The City reserves the right to conduct periodic inspections of collection vehicles to ensure compliance with Federal and State commercial motor vehicle statutes, as well as the above requirements.

The Contractor shall have sufficient reserve vehicles and equipment available to complete daily loading and collection requirements. The use of reserve vehicles and equipment shall include, but not be limited to, occasions when frontline vehicles and equipment are out of service, or when unanticipated delays will prevent frontline vehicles and equipment from completing the Services within the established hours of loading, collecting, and transporting to the MRF.

14. Billing and Payment of Services

The Contractor shall be paid on a monthly basis according to the service fee (per ton) as set out in this Invitation-To-Bid.

15. Contract Terms

The resulting contract will commence no earlier than April 1, 2024 and will be in place for a one (1) year term with an optional four (4) one (1) year renewals, if mutually agreed upon by the CITY and CONTRACTOR (5-year total with renewals). Pursuant to the City of Naples Code of Ordinances, Sec.2-667(7)(e), the term of this contract may be extended by the parties for no more than two (2) years (7-year total with extensions). Each renewal or extension shall be automatically extended for automatic and successive additional terms, unless either party gives written notice to the other not fewer than ninety (90) days prior to the expiration of the then current term.

Should changes in operations occur that may require an alternate disposal/processing location, the City reserves the right to negotiate such changes with the awarded contractor in order to account for cost ramifications that may result from greater (or less) hauling distances. The methodology and logic used for negotiations for rate changes will be established and calculated on a case-by-case basis and will require City Manager approval.

16. Annual Rate Adjustment

The unit price Hauling and Transporting Services shall remain the same through the first year of the Agreement. Beginning April 1, 2025 and each April 1 for the remaining term of the Agreement, the rate shall be adjusted, if requested, in writing, by the Contractor. If a rate adjustment is requested, the adjustment, per annum will be as follows: The rate shall be adjusted based on the percentage

change in the Consumer Price Index, South Urban Region, All Items – All Urban Areas between the month of August in the previous year and the month of August in the current year. The total adjustment to the service rate in any given year shall not exceed five percent (5%) of the previous year's rate without City Manager approval.

The CPI will be the Consumer Price Index for the South Urban Region, All Items - All Urban Wage Earners and Clerical Workers, published by the United States Department of Labor, Department of Labor Statistics.

If the CPI is discontinued or substantially altered, the City may select another relevant price index published by the United States Government or by a reputable publisher of financial and economic indices.

The Contractor may petition the City for an additional rate adjustment resulting from a change in law. The Contractor's request shall contain substantial proof and justification to support the need for the rate adjustment. The City may request from the Contractor such further information as may be reasonably necessary in making its determination. Within sixty (60) calendar days of receipt of the request and all other additional information required by the City, the Department Director shall determine the fairness of the request and shall make a recommendation to the City Manager. Adjusted rates shall become effective upon approval by the City Manager. Any rate increase per product and final acceptance of said increase will be determined by the City. Any adjusted rate shall become effective upon approval by the City Manager.

17. Monthly Reporting

The Contractor shall supply a monthly report to the Project Manager with the following information in a City-approved format.

- Recycle Material Tonnage
- Pickup Count
- Number of Service Complaints (by City of approved MRF)
- Incidents/Injuries

18. Collection Plan

The Contractor shall prepare a collection plan that describes in detail how the Contractor will provide a loading and collection plan in compliance with the requirements in this Invitation-To-Bid.

The loading and collection plan shall identify and describe, at a minimum, the type of equipment being proposed, number of pieces of equipment required, personnel assigned and the methods by which the Contractor will use for complying with the Services required for executing the Program. The loading and collection plan and all revisions to the plan are subject to the Project Manager's prior written approval.

A proposed loading and collection plan shall be submitted to the Project Manager for approval whenever the Contractor requests changes to the loading and collection plan.

19. Contingency Plan

Contractor shall develop a contingency plan that describes the Contractor's plan of action if an emergency, natural disaster or other situation renders the Contractor's operations, yard, or equipment unusable. The contingency plan shall describe the steps that the Contractor shall take to avoid interruptions or reductions in service. The contingency plan shall be updated annually and resubmitted to the Project Manager as requested, or within two (2) days whenever the plan is revised by the Contractor. The Contingency Plan and all revisions to the plan are subject to the Project Manager's approval.

20. Transition Plan

The Contractor will be required to participate in contract kick-off meetings conducted by the Department Director or designee to plan and manage the transition process so that there is no service interruption. However, it shall be the Contractor's responsibility to ensure that there is a smooth transition and implementation of the new Agreement so that inconvenience to hauling and processing of recyclable material is minimized. To assist in accomplishing this smooth transition, no later than thirty (30) Days following the Notice to Proceed, the Contractor shall submit to the City a transition plan that provides a detailed description of how the Contractor will plan and prepare for loading and collection during the transition period.

21. Declared Disaster - Service Requirements

In the event of a hurricane, tornado, major storm or other natural disaster, the Project Manager may grant the Contractor a variance from regular loading and collection schedules. As soon as practical after such a natural disaster, the Contractor shall advise the Project Manager when it is anticipated that normal schedules will be resumed. The Project Manager shall determine when normal loading and collection routes shall be resumed.

22. Declared Disaster Additional Requirements - State or Federal Declared Disaster

In the event of a State or Federal Declared Disaster, the Project Manager may request additional services be provided by the contractor for hauling services at a negotiated rate per cubic yard or per ton (whatever may be in the best interest of the City). If this is requested, the Contractor must comply with all federal and state statutes regarding proper documentation and compensation for such activities, as designated in the requirements of this Invitation-To-Bid.

E. RESPONSIBILITIES OF THE CITY

1. Oversee Contract-

The City shall oversee this contract to ensure that all objectives within the scope of services are met and the highest level of service is provided to City residents.

2. Loading of the Recyclable Material

The City of Naples shall provide all equipment and labor necessary for the loading of the recyclable material into the contractor's trailers and/or containers.

The City shall make every effort to load trailers at an average of 10 tons per load per 100-yard trailer.

3. Ensure Accessibility to Recycle Material

The City shall ensure that the Contractor is able to safely position transport trailers and/or containers for loading and collection for all recyclable material to avoid delays. In the event that a truck cannot easily access the area where recyclable material is loaded, the City shall be notified that an accessible location, agreeable by the Contractor, will be required. If an appropriate location cannot be agreed upon between the City and Contractor, the Project Manager shall mediate the dispute and designate the location for loading and collection. City staff will have limited capabilities to lend support for moving and relocating trailers and/or containers (trailers/containers provided by the contractor) on site for accessibility and loading activities.

F. CONTRACT MANAGEMENT:

The Solid Waste Superintendent and/or his authorized representative will serve as the City's Contract Manager.

G. LICENSES AND PERMITS:

Licenses may be required by the State of Florida, Collier County, or the City of Naples to perform all or part of this work. Contractors should investigate and determine if they hold the necessary License(s) prior to bid submittal. Permitting may be required for all or part of the requested work. The contractor will be responsible for investigating and determining if permitting is necessary. The contractor will also be responsible for obtaining permits.

At a minimum, vendors must submit the following:

1. All licenses necessary to perform all work requested and be certified and or qualified to provide the required services.
2. The contractor shall be responsible for possessing all of the necessary licenses required to do work within the State of Florida, Collier County and the City of Naples. The contractor shall also be compliant with all licenses required to haul and transport material pursuant to the Florida Department of Motor Vehicles and the Florida Department of Transportation regulations.

3. Prospective vendors, whether residents or nonresidents of Florida, must provide evidence of proper licensure with their Bids submittal. Such evidence must be in the form of copies of their Florida license which authorizes Bidder to perform the work.
4. Prospective vendors must hold the required license for the type of work to be performed at the time their bid response is submitted and for the duration of the contract.
5. Prospective vendors must provide a list of the permit(s) they determined are necessary to perform the requested work.

H. INSURANCE

The City's General Insurance Requirements on page 12 apply. In addition to the City's General Insurance Requirements, the specialized insurance listed below is required:

- Certificate of Insurance: Proposer must provide proof of insurance in the form of a Certificate of Insurance that complies with the City's General Insurance Requirements and Umbrella Liability with limits of not less than \$5,000,000 per occurrence.

I. SUB-CONTRACTORS AND MATERIAL SUPPLIERS

If the prospective contractor contemplates the use of sub-contractors, as a further condition of award of a contract, the prospective contractor must certify in writing that all of its sub-contractors are appropriately licensed and are registered with the State of Florida in accordance Florida Statutes Chapters 607 or 620, and such statement will include any sub-contractors' corporate charter numbers. For additional information on registering, the prospective contractor should contact the Florida Secretary of State's Office.

Each prospective contractor must submit a list of all proposed sub-contractors, material suppliers, and equipment intended for this project. No changes to this list shall be made without the express written consent of the City. Any request for changes shall be made in writing, to the City, clearly stating the reasons for the change. The City reserves the exclusive right to either approve or reject such request for change. Contractor agrees that the City's or its consultant's decision is final and binding. Contractor understands and agrees that he/she is solely responsible to the City for all work specified herein; and, that subsequent review of sub-contractors and/or material suppliers by the City or its consultants does not relieve the contractor and/or his surety of any liability or obligation stipulated herein. Failure to comply with the above may result in termination of this contract.

All bidders must provide requested information in the attached forms provided.

J. CONDUCT

The awarded vendor(s) and his employees will conduct themselves in such a manner as to avoid embarrassment to the City of Naples and must at all times be courteous to the

public. Although uniforms are not required, proper clothing must be worn at all times to include shirts, necessary safety equipment, pants, short or long, and proper footwear. Proper safety equipment must be worn at all times.

K. CONTRACTORS EQUIPMENT

All vehicles and equipment must be maintained in good repair, appearance and sanitary condition at all times. Vehicles must be clearly identified with the name of the company and phone number clearly visible. In addition, the contractor will be responsible for using the necessary safety equipment according to State standards while working on City, County, or State roads as a sub-contractor of the City.

L. DISPOSAL OF DEBRIS

The awarded vendor(s) shall dispose of all debris and other materials gathered from the described work in compliance with all applicable federal, state, county, city, and local regulations.

Remove leftover materials, trash, debris, from project site and surrounding areas daily.

M. SCHEDULING OF WORK

1. All work will be performed Monday through Friday from 7AM to 4PM.
2. The awarded vendor(s) will correct work deficiencies and/or problems pointed out by the Contract Manager within 3 days of notification or sooner depending on the nature of the deficiency.

N. PAYMENT REQUESTS, INVOICES AND WORK REPORTS

1. Invoices shall be submitted after work is completed with a detailed description of the work performed.
2. The awarded vendor(s) will meet with Contract Manager and set up procedures prior to the start of work.

O. NON-PERFORMANCE

The City reserves the right to cancel the contract with a seven (7) day notice should the Contractor fail to perform up to the requirements and standards identified in the specifications. The City may withhold part or all payments due to the awarded vendor(s) until correction is made.

P. QUALIFICATIONS

Prospective vendor(s) must be licensed with a minimum of five (5) years' experience in related work. All bidders must provide, with their bid proposal, a list of at least three (3) commercial references of completed specific projects and send the attached reference questionnaire to the client who will submit the completed form directly to the City. The City reserves the right to contact these as references, in order to determine the competency of the Contractor.

Q. INSPECTION

The City reserves the right to make inspections and tests, when deemed advisable, to ascertain that requirements of the contract are being fulfilled. Should it be found that the standards specified are not being satisfactorily maintained, the City will immediately demand that the contractor comply with the Invitation to Bid to meet these requirements.

The Contract Manager will make visits to the site at intervals appropriate to the various stages to observe the progress and quality of the executed work and determine if the work is proceeding in accordance with the Contract Documents. Contract Manager may authorize minor variations from the requirements of the Contract Documents.

R. PROTECTION OF FACILITIES, PUBLIC AND PRIVATE PROPERTY

1. From the time the awarded contractor commences and until final acceptance by the City of any work specified on the Invitation to Bid, awarded contractor is required to initiate and maintain measures which shall be proper and adequate to protect the building, its contents and any surrounding areas against damage by the elements. The contractor shall assume full responsibility for any damage to any property including but not limited to walls, floors, tables, chairs, trees, shrubs, lawns, walks, pavements, roadways, structures, utilities, and underground facilities, resulting from the performance of the work.
2. Further, the awarded contractor must at all times guard against damage or loss to the property of the City or of other vendors or contractors and shall be held responsible for replacing or repairing any such loss or damage. The City may withhold payment or make such deductions from payments as it deems necessary to insure reimbursement or replacement for loss or damage to property through negligence of the awarded contractor or his agents.
3. Further, provide adequate protection for both curbs/sidewalks/grass areas over which trucks and equipment pass to reach the project site and repair/replace all damaged areas, at no cost to the owner.
4. The contractor upon receipt of either written or oral notice shall immediately discontinue any practice obviously hazardous in the opinion of the Contract Manager. The contractor shall comply with all OSHA and other Federal and State safety standards. Blocking of the public street, except under extreme emergency conditions, shall not be permitted unless prior arrangements have been made with the Contract Manager and the City Police and Fire Departments and other agencies having jurisdiction over the street to be closed.

S. PROTECTION OF OVERHEAD UTILITIES

The operations will be conducted in many areas where overhead electric, telephone, and cable television facilities exist. The contractor shall protect all utilities from damage, shall immediately contact the appropriate utility if damage has occurred, and shall be responsible for all claims for damage due to his operations. The contractor must make arrangements with the utility for the removal of necessary limbs and branches, which may

conflict with, or create a personal injury hazard in the removal of the tree. Delays encountered by the contractor in waiting for the utility to complete its work shall not be the responsibility of the contractor.

T. PROTECTION OF UNDERGROUND UTILITIES

The Contractor will be responsible for following the Florida Underground Facility Damage Prevention & Safety Act (556), OSHA Standard 1926.651, Florida Trench and Safety Act (Chapter 90-96) and obtaining utility locations by calling Sunshine State One-Call of Florida Inc. at 1-800-432-4700. Contractor shall have full responsibility for reviewing and checking all information and data for locating all underground facilities.

U. TRAFFIC CONTROL

1. Contractor will be required to furnish traffic control and/or barricades as needed or as required by the State of Florida. Barricading and detouring of the traffic shall be accomplished in conformance with the State of Florida Manual of Uniform Traffic Control Devices for Highway Construction and Maintenance Operations, latest edition. A flagman is required when two-way traffic is obstructed by the removal operation.
2. Contractor will be responsible for adequate barricades, warning devices, and the necessary safety equipment according to State DOT standards while working on City, County or State roads as a sub-Contractor of the City.

V. PRE-PERFORMANCE CONFERENCE

Schedule a pre-performance conference with City staff at least 7 days before beginning work to review any questions the Contractor may have regarding the work, administrative procedures during construction and project work schedule.
